Volunteer Role Description

The purpose of this role

As a Member of a National Council, you'll represent and advocate on behalf of people affected by MS in the nation you serve, within the governance framework of the MS Society.

You'll contribute to the delivery of an annual plan of activity to fulfil the Council's purpose, developed by the Council and approved by the Board.

What the role involves

- Representing the views and perspectives of people affected by MS in the nation you serve, within the governance framework of the MS Society.
- Acting as an ambassador for the MS Society, and upholding our values.
- Promoting the MS Society to maximise our income generation and engagement.
- Promoting and supporting our Volunteering Programme in the nation you serve.
- Contributing to the development of the Council's annual plan.
- Contributing to the development of the MS Society's strategy and annual plan, including in particular through identifying specific national issues.
- Promoting communication between people affected by MS, staff, and the Board.
- Upholding all decisions properly made by the Council.
- Preparing thoroughly and participating fully in Council meetings.
- Using your specific skills, knowledge and experience to help the Council reach sound decisions.
- Maintaining appropriate confidentiality, disclosing any conflicts of interest and abiding by the MS Society's Code of Conduct, policies and procedures at all times.

- The ability to operate effectively as part of a team.

- An understanding and appreciation of the purpose of the Council and a commitment to attend all meetings and undertake associated tasks.
- The ability to communicate with a wide variety of people and organisations, including the ability or potential to speak at public engagements.
- The ability to act as an ambassador for the MS Society.
- A commitment to diversity, equality and inclusion.
- A commitment to the time required to fulfil your role.
- A commitment to developing networks that enable you to understand the views of people affected by MS in the nation you serve, in order to share those views within the Council and, via the Chair of the Council, with the Board of Trustees.

Expected time commitment

Members of National Councils are expected to contribute to four National Council meetings per year and to engage with MS community networks and local staff teams between meetings.

You will also be expected to take part in an induction programme and ongoing development.
